Course Description:

This course focuses on the diagnosis, treatment and understanding of psychopathology and abnormal behavior. Psychological disorders will be fully examined in terms of symptomology, etiology, and assessment through use of the DSM-IV-TR and the text. In addition, students will learn how to use and apply the DSM-IV-TR to case vignettes in preparation for future clinical work. Cultural implications of diagnoses will also be discussed.

Course Objectives:

The primary objective of this course is to introduce students to psychopathology and the DSM-IV-TR. By the end of this course, students should be able to:

a. Understand the components and diagnostic criteria of major Axis I and Axis II disorders.

b. Create a complete five Axis Diagnosis based on case material.

c. Use the DSM-IV-TR in the context of diagnosis.

d. Search for and apply recent scholarly research to specific diagnoses.

e. Clearly differentiate between DSM-IV-TR diagnostic criteria.

f. Diagnose disorders of childhood, and be able to differentiate these disorders from adult categories and symptoms.

g. Comprehend an introduction to the theoretical basis of Axis II Personality Disorders.

Methods of Instruction:

This is a 14 week on-campus course. The instructor combines lecture with group work and discussion. Please be prepared by having read the assigned chapters before the beginning of class. Students will need the DSM-IV-TR for every class in order to participate fully. There is one midterm and one final exam. These exams are multiple choice and short answer. There will be a research paper due the second to last week of the course the parameters of which will be discussed during our first meeting. Periodically I will require short homework assignments that will be directly related to the lesson assigned that week. Attendance and class participation will be vital to your overall success in this course.
