Course Description: In this course we will examine common ethical issues that arise during the course of psychotherapy, assessment, and general therapeutic practice. By the end of the term students should be familiar with the American Psychological Association's Ethical Principles and Codes of Conduct and apply ethical principles to a meaningful context within a therapeutic setting. The course will emphasize cultural aspects of ethics, specialty guidelines for underserved populations, and guidelines specific to working with children and families.

Course Format:

Class meetings will occur each Monday, from 2:00 to 5:00. Note: The class will not meet on the following holidays: 1/15/07 (Martin Luther King Day) and 2/19/07 (President's Day).

Course Objectives: The primary goal of the course is to introduce students to the ethical and legal boundaries and responsibilities of clinical practice. Through the text, case vignettes, and classroom discussion, students will:

- a) Gain an historical perspective concerning the progression of ethics in the behavioral and social sciences.
- b) Develop an understanding of ethical principles and codes of conduct of therapists in clinical and counseling settings.

- c) Familiarize themselves with research relevant to ethical behavior of therapists across various modalities, including but not limited to, sexual misconduct, multiple relationships, informed consent, fee collection, mandated reporting, and communication of information.
- d) Traverse common ethical dilemmas and sources of potential violations.
- e) Conduct an in-depth analysis of a contemporary ethical issue facing therapists.

Methods of Instruction: In addition to discussion of reading assignments, methods of instruction will include lecture and analysis of case vignettes (typically in a group format). The instructor will endeavor to integrate visual and audio learning modalities into the lecture to enhance learning acquisition. This course does not include an online component.

Student Performance Evaluation Criteria and Procedures: Your performance will be evaluated in four ways: a written assignment, a verbal presentation, a midterm exam, and a final exam.

Written Assignment (60 points): Conduct a scholarly review and critical analysis of a contemporary ethical or legal issue impacting the field of counseling. Your paper should include at least five references other than your textbook. These should be books, articles or periodicals. You *may* include additional references, including websites, but at least two must be as described. Your paper will be graded on following the instructions, writing clarity, and level of applied thoughtfulness. Written assignments are due on 4/12/07.

<u>Verbal Presentation (40 points):</u> You are to present a brief (8-10 minutes) classroom presentation of the essential findings of your written assignment. You will be graded according to your presentational style and expertise within the content area. <u>Verbal presentations will occur on 4/12/07.</u>

Midterm [2/26/07] (100 points) and Final Examinations [4/16/06]: The purpose of midterm and final examinations is to assess students' comprehension of course subject matter. Examinations will consist of multiple choice questions, short-answer essay, and analysis of vignettes.

NOTE: The Final Examination is a comprehensive examination and will cover content throughout the entirety of the course, including verbal student presentations.

Grading: Student grades will be based upon the following:

Written Assignment = 60 points Verbal Presentation = 40 points Midterm Examination = 100 points Final Examination = 100 points Total = 300 points

Criteria for Class Presentation

Grade

A = 90+ Presentation is well organized and provides **excellent** coverage of the topic area.

B = 80 - 89 Presentation is well organized and provides adequate coverage of the topic area

C = 70 - 79 Coverage of material is marginal; presentation is slightly disorganized

F = <70 Presentation is **disorganized** and does not provide adequate coverage of the topic area, or presentation was **not completed** by student.

Criteria for Paper

Grade

A = 90+ Paper is in appropriate APA format, well thought out and provides **excellent** coverage of material

B = 80 - 89 Paper is well thought out, but is missing one component of APA format OR coverage of material is **adequate**

C = 70 - 79 Insufficient number of references provided AND **limited** coverage

F = <70 Paper is disorganized AND coverage is not adequate AND does not conform to APA format, or there is evidence of **plagiarism**, or paper not submitted
