Frequently Asked Questions Center for Special Problems – Professional Training Program

HIGHLIGHTS

- Trainees provide individual therapy lasting up to one year with each client and they each co-lead a group with a staff person. Each trainee sees clients from each of CSP's program areas Trauma Resolution, HIV, Gender, and Offender Services.
- All clients are adults: a) Trauma survivors, b) Persons with HIV, c) Persons with gender issues, and d) Perpetrators of domestic violence, non-domestic violence, or a sex offense.
- Individual therapy is provided to the trauma survivors, persons with HIV, and persons with gender issues. The perpetrators of domestic violence or a sex offense are almost exclusively seen in groups rather than individual therapy.
- Trainees receive weekly individual supervision, and they attend a weekly didactic seminar and biweekly group supervision. They are also given opportunities to observe staff doing therapy.
- The clinic has 25 licensed mental health clinicians on staff: Twelve LCSWs, six MFTs, three psychologists, three psychiatrists, and a psychiatric clinical nurse specialist. This gives trainees ongoing opportunities to consult with staff regarding clinical issues.
- Trainees can choose to co-lead a Dialectical Behavior Therapy (DBT) group with a staff person.

What is the Center for Special Problems?

The Center for Special Problems (CSP) is an outpatient clinic of the San Francisco Department of Public Health, Community Behavioral Health Services. Since 1957, this agency has provided specialized counseling, medication, and case management services to San Francisco residents. CSP is focused on working with adults who are coping with mental health issues related to trauma, gender non-conformity, HIV disease/AIDS, and violent impulses. The agency serves an ethnically and culturally diverse population with a multidisciplinary, multilingual, and culturally sensitive staff.

CSP's services are provided through the following programs:

Trauma Resolution Program

This program provides trauma-focused treatment to individuals who have experienced or witnessed an extremely traumatic event that included actual or threatened death, serious injury, or a threat to the physical integrity of self or someone else. The program is designed to help individuals who are suffering from psychiatric symptoms caused by their traumatic experiences to better manage their symptoms and to improve their ability

to function in daily life. The program provides individual and group counseling, psychiatric medication services, and case management. It is our aim to ensure that each client receives the services that are most appropriate and beneficial to their specific needs.

Gender Program

Mental health care provided addresses concerns related to gender non-conformity. Individuals may be confused or struggling with their gender identity, may need information and support to transition, or may be dealing with discrimination or social rejection related to gender non-conformity. Individual psychotherapy, psychiatric medication services, and case management are offered.

HIV Mental Health Case Management Program

Many individuals who are HIV-positive are also dealing with HIV-related psychiatric issues. The Center for Special Problems offers mental health case management services including assessment, individual and group psychotherapy, and psychiatric medication support. CSP also offers an HIV Consultation Service to other health care providers. This program is partially funded through CARE Grants.

Offender Services Programs

Services are provided for a variety of clients who are perpetrators of interpersonally violent, destructive, or sexually abusive behaviors that might have led to involvement with the criminal justice system. CSP has the following programs for such clients:

- <u>Domestic Violence</u>: A certified program designed for men and women on diversion, probation, or parole for domestic violence. The program offers a minimum 52-week intensive group therapy focusing on assisting clients to take responsibility for non-violent behavior at all times. Groups for men and women are offered separately. Case management, individual counseling, and psychiatric medication services are available when appropriate.
- <u>Non-Domestic Interpersonal Violence</u>: This program is designed for clients who threaten, stalk, or assault others in a non-domestic context. The program provides counseling services as well as psychiatric medication services and case management when appropriate.
- <u>Sex Offender</u>: This treatment program offers intensive, focused group therapy designed to assist sex offenders in reducing the risk of reoffending. The goal is to help increase the safety of all members of our community. Case management and psychiatric medication services are available when appropriate.

What clinical services do the trainees provide?

Trainees provide individual therapy, intakes, and case management, and they each co-lead a group with one of our staff. Each trainee is expected to work with clients from all of CSP's programs: Trauma Resolution, Gender, HIV, and Offender Services. Almost all of the Offender Services clients are seen in group rather than individual therapy.

What training and supervision do the trainees receive at CSP?

- a) Individual supervision: Each trainee receives weekly individual supervision.
- b) <u>Didactic seminar and group supervision</u>: All the trainees attend a weekly trainee meeting on Thursdays from 8:30 to noon. Each week, this meeting includes a 75-minute didactic seminar that focuses primarily on clinical issues involved in working with the client populations we serve. In addition, every other week, the meeting on Thursday morning includes two hours of group supervision, in which the trainees discuss clinical issues they are facing in their work with clients at CSP. In group supervision, trainees are asked to play a small portion of an audiotape of a recent therapy session. Every other week, alternating with group supervision, the trainees view and discuss a videotape of a staff person conducting psychotherapy with a CSP client.
- c) <u>Participation at all-staff meeting and on staff teams</u>: On Monday afternoons each week, the trainees attend the all-staff meeting and the program meetings for each of the various CSP programs Trauma Resolution, Gender, HIV, and Offender Services.

Also, each trainee is a member of a multidisciplinary "Duty Office" Team, typically including a psychiatrist, an MFT, LCSW, and/or a psychologist, and a peer support staff person, in addition to one or more trainees. This Team meets weekly to provide consultation to one another regarding intakes of prospective clients.

What theoretical orientations are used at CSP?

The theoretical orientation at the clinic is diverse – cognitive-behavioral, psychodynamic, existential-humanistic, narrative.

In the group supervision sessions, which occur every other week as noted above, we also incorporate Motivational Interviewing and Harm Reduction into the discussions.

When does the training year start and end?

The 2007-08 training year starts on September 10, 2007 and ends on June 30, 2008.

How many trainees does CSP have each year?

We have up to seven trainees each year – typically a mix of MFT trainees and interns, social work interns, doctoral psychology practicum trainees, and post-doctoral psychology interns.

What hours do trainees work at CSP?

Trainees are expected to work 20 hours per week. Required weekly hours are:

- Mondays, 1:00 to 5:00, for clinic staff meetings
- Thursdays, 8:30 AM to noon, for the trainee seminar and group supervision
- One three-hour shift each week as a member of a "Duty Office" team, which involves doing intakes and phone screening of prospective clients either Mondays, Wednesdays, or Fridays from 9:00 AM to noon, or Tuesdays or Thursdays from 2:00 to 5:00 PM (each trainee chooses one of these shifts).

On Monday, September 10th – the first day of the 2007-08 training program – trainees are expected to attend an initial orientation from 11:00 AM to 5:00 PM.

Beyond the above-noted required days and times, trainees can choose the remainder of their weekly work schedule within clinic operating hours, which are Mondays and Wednesdays from 8:00 AM to 8:30 PM, Tuesdays and Fridays from 8:00 AM to 5:00 PM, and Thursdays from 8:00 AM to 7:30 PM.

Do trainees get any vacation time?

Trainees get three weeks of vacation: Two designated weeks during the Christmas holidays, and one designated week for Spring Break.

Is there a stipend?

Unfortunately we do not offer all trainees a stipend. However, trainees can apply for a multicultural student stipend of \$1800 - \$3500 per year, offered by the City and County of San Francisco. The application process for this stipend is a competitive one, and, in the past, at least one CSP trainee has usually been awarded the stipend each year.

What are the prerequisites in order to apply for the training program?

Applicants must be enrolled in – or they must have completed – a master's or doctorate level program in social work, counseling, or psychology.

By the time they start at CSP, trainees must have completed a previous supervised, graduate-level internship or practicum in a mental health setting.

We do not expect applicants to have had prior clinical experience working with the particular populations served by our clinic.

What is the application process?

Application materials should be received by us no later than March 5, 2007.

Social Work and MFT-track applicants:

To apply, send us the following:

- a cover letter stating why you are interested in training at the Center for Special Problems
- your résumé or curriculum vitae
- two letters of recommendation, including at least one from your supervisor at your current or most recent internship or practicum.

Doctoral Psychology Practicum applicants:

To apply, send us the following:

- a completed Application for Doctoral Psychology Practicum Training (please contact David Silven at david.silven@sfdph.org, to request this form)
- your résumé or curriculum vitae
- two letters of recommendation, including at least one from your supervisor at your current or most recent practicum.

What happens during the interview?

The interview lasts 45-50 minutes, and there is only one interview required. Two or three of our staff will be present during the interview.

As part of the interview, we ask the candidate to give a brief thumbnail sketch – for no more than five minutes – of his or her work with one adult or child client during the past year. If the candidate hasn't worked with any clients during the past year, it's okay to choose a client the candidate saw more than a year ago. For this thumbnail sketch, the candidate doesn't need to give us anything in writing. The interviewers will want to hear the candidate talk primarily about what he or she did or tried to do in the work with the client.

Where is CSP located?

Our address is 1700 Jackson Street. We're located at Jackson and Van Ness in San Francisco, near the northwest corner of that intersection. You'll see the First Republic Bank on the corner, and our entrance is just up Jackson Street from the bank.

If you're taking public transportation, the Van Ness buses stop at Jackson Street. If you're driving, we suggest you allow some extra time to find street parking, and you should be able to find two-hour street parking within about two or three blocks from us.
