III. AGENCY DESCRIPTION: Please describe below.

MTC is a nonprofit, outpatient community agency providing comprehensive addiction services, including opiate detox, methadone/suboxone maintenance therapy, outpatient therapy, drug diversion, Prop 36 program, drug free counseling. We also have available HIV/Hepatitis C testing, case management and primary care services for our clientele. Clients on methadone maintenance are long-term clients, some being on the program for over 20 years. There is a diversity of backgrounds, addiction histories and presenting issues, ranging from young adult “first timers” in treatment, to those successfully abstinent from illicit drug use for many years. There are clients with dual and triple diagnoses, (eg., addiction, AxisI/II, and HepC/HIV). There is a team approach to treatment with nurse, physician and at times, case management taking part in client care.

VI. TRAINING/SUPERVISION PHILOSOPHY and OBJECTIVES: A. Please describe below.

Trainee will learn both drug counseling model and a long-term, process-oriented model and be able present cases from both perspectives. Active support in program for formal case presentations. Students keep same caseload for entire year, but also have brief therapy experience through work with short term detox clients. Training in Hepatitis C/related medical issues, HIV prevention, smoking cessation, medication issues, addiction, narcotic replacement therapy, crisis intervention, substance abuse detection, and psychotherapy theory and technique. Opportunity to learn forensics thru Proposition 36 program, and chance to do intake assessments. Trainees will have hands on experience, with support from group. Supervision is based on collaboration, mutually agreed upon goals with focus on professional development and skill-based competencies.
