The training/supervision philosophy of the Oak Vet Center is to bring out the strengths of each student while providing theoretical information to assist with assessment; case formulation/conceptualization; intervention via individual psychotherapy and group. Training is done where the student will observe the therapist initially. Following this the student will then be observed while seeing clients and when adequate skills are shown then the student will engage in individual, couples, and group psychotherapy with supervision. Students will meet with supervisor and develop a list of what they would like to learn while here at the Oak Vet center while supervisor will talk about expectations with regards to assessment, case formulation, interventions during therapy as well as being able to consult, write progress notes and psychosocial reports, and be able to present cases.
