III. AGENCY DESCRIPTION: Please describe below.

The Center for Behavioral Health is 61-bed psychiatric hospital serving children, adolescents, adults and geriatric patients in inpatient and partial hospitalization/day treatment settings. It is fully accredited by JCAHO and HCFA. Services are provided by a multidisciplinary team and focus on rapid stabilization fro patients with acute psychological symptoms. An inpatient eating disorders program began in Fall 2004. The duration of the practicum is one year including four weeks vacation. Opportunities for research and teaching are also significant parts of the program. The hospital has a history of appreciation and support of our practicum students' work.
