

Argosy University/SFBA Payment Plan Agreement



1. Payment Plan for Students Registering before Completing their 2006-2007 Financial Aid application Material:

Students intending on completing the 2006-2007 FAFSA and the 2006-2007 Institutional Application and would like to register online are **required** to fill out this payment plan form and turn into the campus during pre registration week. This agreement will give the student until April 1st to turn in the confirmation print out of the 2006-2007 FAFSA and the 2006-2007 Institutional Application. If the indicated forms have not been turned in by April 1st, 2006 the student's tuition will be put on a payment plan and $\frac{1}{4}$ of the tuition plus the \$35 payment plan fee will be charged to the credit card listed below. This form will be kept on file until the first 2006-2007 disbursement.

2. Payment Plans For Students not on 2006-2007 Financial Aid:

Payment Plans are available to cover balances due on student accounts by making pre-arranged credit card/debit card payments. $\frac{1}{4}$ of the balance due will be paid if the student fails to turn in required financial aid documents by April 1st, 2006. The remaining three payments will be due on the first day of the term, 1 month after the first day of the term and 2 months after the first day of the term. Changes to a student schedule after a payment plan is set up will be handled as a separate transaction using the add/drop form (see below). Payment Plans are \$35/ term.

3. Add/Drop Period and Payment Plan:

If a student makes an adjustment to their schedule which effects the total balance due of the original payment plan, **students payment plan will remain at the same amount until the total balance is paid off.** Students adding classes resulting in a higher balance due, will need to pay in full for the class added when submitting the add/drop form with the appropriate payment. Students will not be refunded their Payment Plan Fee of \$35 if they drop a class.
